On December 21, 2017, Transocean Ltd. (the "Company") announced that the harsh environment semisubmersible *Transocean Spitsbergen* was awarded a 22-well contract with an estimated duration of 33 months; plus two one-well options in the Norwegian North Sea with Statoil Petroleum ASA. The estimated firm backlog associated with the contract is approximately \$286 million, which excludes opportunities for performance incentives. The contract is expected to commence in the third quarter of 2019.

ZUG, Switzerland—December 21, 2017—Transocean Ltd. (NYSE: RIG) announced today that the harsh environment semisubmersible *Transocean Spitsbergen* was awarded a 22-well contract with an estimated duration of 33 months; plus two one-well options in the Norwegian North Sea with Statoil Petroleum ASA. The estimated firm backlog associated with the contract is approximately \$286 million, which excludes opportunities for performance incentives. The contract is expected to commence in the third quarter of 2019.
