1. On July 13, 2005, the reporting person was awarded a contingent, performance based grant for an opportunity to earn 15,020 restricted shares. This opportunity was subject to the satisfaction of certain performance criteria based upon specified peer groups. Depending upon the issuer's performance within the peer groups, the reporting person could earn some, all or none of the shares. The issuer's actual performance resulted in 8,712 restricted shares being granted, which vest as follows: 2,904 on March 19, 2007, 2,904 on January 1, 2008 and 2,904 on January 1, 2009.

2. On July 13, 2005, the reporting person was awarded a contingent, performance based grant of 26,750 stock options, which were subject to the satisfaction of certain performance criteria based upon specified peer groups. Depending upon the issuer's performance within the peer groups, the reporting person could earn some, all or none of the options. The issuer's actual performance resulted in options to purchase 15,515 shares being earned, which vest as follows: 5,171 on March 19, 2007, 5,172 on January 1, 2008 and 5,172 on January 1, 2009.
