On September 4, 2024, Transocean Ltd. announced that Reliance Industries Limited awarded the *Dhirubhai Deepwater KG1* a binding Notification of Award for six wells offshore India. STEINHAUSEN, Switzerland—September 4, 2024—Transocean Ltd. (NYSE: RIG) ("Transocean") today announced that Reliance Industries Limited awarded a binding Letter of Award for the *Dhirubhai Deepwater KG1* for six wells offshore India. The estimated 300-day program is expected to commence in the second quarter of 2026 and is estimated to contribute approximately \$123 million in backlog, excluding additional services and a mobilization fee. The award also includes multiple options. If all options are exercised, the rig would remain in India through the end of 2029.
